There is no doubt your are wondering when and how the Masonic Building at 650 Fisgard St. Will re open. The following will be the process we undertake to be able to once again enjoy and safely meet.

Monday December 13,2021

This will be the date we restart meeting in the building. To begin with lodges will be able to meet once in December on either their regular meeting time or their GP/Practice. This will be more for your orientation and becoming acquainted with the building and the reuse as laid out by the Grand Master. However at this time the third floor refreshment area will not be open for use and no festive boards. This is largely due to the required sanitization before and immediately after the use. Also we are not yet comfortable with food prep and serving techniques. Please have patience as this is one step at a time and we will get there...COVID is still very much with us.

Beginning in January lodges may meet for their Regular meetings. At this time because of the sanitization requirements only the historical annual regular meetings will be permitted.
